



RESOLUTION 2025-1017

RESOLUTION ESTABLISHING ESTIMATE OF TAX LEVY FOR 2025

WHEREAS, the Board of Commissioners of the Harrisburg Township Park District, Saline County, Illinois (“the Board”) is to determine the amount of money to be raised by the property tax levy at least 20 days prior to adopting the new levy ordinance (35 ILCS 200/18-60).

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE HARRISBURG TOWNSHIP PARK DISTRICT, SALINE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: Estimate of Tax Levy for 2025

SECTION TWO: All of the above figures were used from actual 2024 tax levy for monies to be received in 2025. The assumptions used for the 2025 tax levy for revenues to be received in 2026 is not to exceed 105% of the previous year tax base or levy amounts. The 2024 total extension of \$573,290.37 x 105% equals \$601,954.89. Since the total aggregate Estimate of Tax Levy for 2025 is not greater than 105% of the preceding year's extension, a public hearing is not required.

SECTION THREE: Any and all policies, resolutions or ordinances of the Harrisburg Township Park District which may conflict with this resolution shall be, and they are hereby, repealed.

SECTION FOUR: This resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.


